1. I herewith irrevocably permit Leipzig University Library to permanently archive and maintain the electronic version of the above mentioned document in full text format as well as to publicly provide it on Leipzig University Repository for the free use on the internet. Leipzig University Library is allowed to transfer the document including the descriptive data I provided (metadata) on equal terms to other libraries and archives, especially to the German National Library and the DFG Special Subject Collection libraries. 4. Leipzig University Library is allowed to alter data if technical development so requires (e.g. data migration for the sake of long-term preservation of digital documents). This may not lead to any changes in content. I am entitled to withdraw my publication from the server when the Leipzig University Library should not be able to ensure archiving and public access.
5. The entry of birth date and birth place is voluntary. I agree with the saving of these data in Personennormdatei (PND) and the publication on the Internet.
